SUSPECTED OR CONFIRMED CASES OF COVID-19 IN FLORIANÓPOLIS MUNICIPAL EDUCATIONAL UNITS

CASES TRACKING



ALL EDUCATIONAL UNITS MUST KEEP TRACKING OF COVID-19 CASES, REINFORCING WITH THE EDUCATIONAL COMMUNITY THE NEED TO INFORM THE EXISTENCE OF **CONFIRMED CASES**, **SUSPECTED CASES** OR THEIR **CONTACTS**.

WE CONSIDER **CONFIRMED CASES** THOSE THAT PRESENT POSITIVE TEST FOR COVID-19.



WE CONSIDER **SUSPECTED CASES** THOSE THAT PRESENT TWO OR MORE SYMPTOMS ACCORDING TO SES ORDINANCE N°. 1101 OF OCTOBER 5, 2021.

WE CONSIDER CONTACTS* ALL PEOPLE WHO HAD DIRECT CONTACT WITH THE SUSPECTED OR CONFIRMED CASE, BETWEEN TWO DAYS BEFORE AND THE TENTH DAY AFTER THE ONSET OF SYMPTOMS, FOR A PERIOD OF 15 MINUTES WITHOUT USING PROTECTIVE BARRIERS (SURGICAL MASK, PFF2 OR SIMILAR), WITHOUT KEEPING PHYSICAL DISTANCE OF 1.0 M IN THE CLASSROOM AND 1.5 M IN OTHER SPACES OR WHO HAD DIRECT PHYSICAL CONTACT (HUG, HANDSHAKE, TOUCH), OR WHO SHARED COMMON MATERIALS, OR WHO HAD A SNACK OR MEALS NEARBY.



***WHEN THE SUSPECTED OR CONFIRMED CASE IS AN ADULT, HE/SHE MUST MAKE THE DECLARATION OF WHO ARE THE CONTACTS.**

HOW TO PROCEED IF SUSPECTED CASES ARE IDENTIFIED



If a symptomatic case is identified in an **adult**, he/she should be instructed to seek medical attention immediately (Alô Saúde Floripa, Health Center or other) for evaluation and scheduling of a test if it is considered a suspicious case.

If a symptomatic case is identified in a **child**, the Educational Unit must guide parents or legal guardians to seek medical care immediately (Alô Saúde Floripa, Health Center or other) for evaluation and scheduling of a test if it is considered a suspicious case.



The Educational Unit management will communicate to the Municipal Epidemiological Surveillance by the email notificaeducacao@gmail.com informing the complete data* of the suspected case and the list with the full name of the contacts for leave**.



***complete data:** full name, CPF, student or teacher, gender, date of birth, patient's telephone number, patient's mother's full name, zip code, address, district, city and state.

**** Leave:** When the contact is a professional from the Educational Unit (teaching staff, civil servant and outsourced worker), he/she, at the time of communication, must sign the Home Restriction Term with the Educational Unit management.

HOW TO PROCEED IF SUSPECTED CASES ARE IDENTIFIED



When the contact is a **child**, the family, at the time of communication, must sign the Home Restriction Term with the Educational Unit management.

When a symptomatic case is considered a suspected case after medical evaluation, he/she must present to the Educational Unit's management the Home Isolation Term and the date of scheduling the test within 48 hours, for internal registration and control.



When the symptomatic case is not considered a suspected case after medical evaluation, he/she must present to the Educational Unit's management, a medical certificate stating that it is not a communicable disease.

When the suspected case is confirmed, after the test result, the Unit's management must forward the complete data of all contacts to the Epidemiological Surveillance to proceed with their testing.

HOW TO PROCEED TO RETURN TO PRESENTIAL ACTIVITIES



SUSPECTED CASES AND THEIR CONTACTS MAY RETURN TO PRESENTIAL ACTIVITIES, AS LONG AS:

- The symptomatic person presents an RT PCR test (nasal swab or saliva) collected between the 3rd and 8th day after the onset of symptoms with a “non-reactive” or “negative” result; or,
- He/She has two tests with a negative result (RT Antigen+ RT PCR); or,
- He/She has the case discarded with a medical certificate stating that it is not a communicable disease.



CONTACTS OF POSITIVE CASES MAY RETURN TO PRESENTIAL ACTIVITIES, AS LONG AS:

- They present RT PCR test (nasal swab or saliva) collected between the 5th and 12th day after the last contact with the positive case with the result “non-reactive” or “negative”; or,
- They have two tests with negative result (RT Antigen+PCR); or,
- They have been released by the Epidemiological Surveillance.
